Dogs Eligible to Enter

This event is open to all dogs classified as Miscellaneous or are an approved Foundation Stock Service (FSS) dog, four (4) months of age or older that are registered with the American Kennel Club. No Champions of Record may compete in an Open Show. No spayed or neutered dogs. Professional handlers are not permitted to exhibit in Open Shows, **with the exception of dogs of which they are the recorded owner/co-owner.** Professional handlers are defined according to the *Rules applying to Dog Shows*, Chapter 3 Section 7. Dogs should be physically sound. No dog shall be judged if it is taped, bandaged, glued or stitched anywhere including ears or tail in any way or has anything attached to it for medical purposes. Refer to chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

OWNERS/EXHIBITORS OF FOREIGN REGISTERED DOGS

If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1. The dog show rules are posted on the AKC Web site at: <http://images.akc.org/pdf/rulebooks/RREGS3.pdf> Most important to note are the following: 1. Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class. 2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. Returned checks do not constitute a valid entry and the Show Secretary will add a collection fee to the amount of each returned check. Day of show entries paid by credit card will be assessed an additional \$2.50 fee. Post Dated Checks, Returned Checks and Declined Credit Cards do not constitute a valid entry fee. The Greenwich Kennel Club and the Longshore-Southport Kennel Club and their agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers or to any of their dogs or property and further assume no responsibility for injury to children. The Greenwich Kennel Club and the Longshore-Southport Kennel Club reserve the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against either organization or any official thereof. **All dogs must be on leash** at all times when on event grounds. No retractable leads, electronic or prong collars, please.

Refunds:

No entry fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committees. No entry fee will be refunded in the event a dog is absent disqualified, excused or barred from competition by the action of the Show Committees.

Ringside:

Dogs should arrive a minimum of one half hour prior to judging. All dogs not needed for further judging will be excused. **Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. R.V. Parking Information:

- Gate will be open Thursday, June 4th from 2:00 P.M. to 8:30 P.M. for RVs and will reopen at: 6:00 A.M. on Friday, June 5th.
- Overnight R.V. on the show grounds by reservation is \$45.00 each day per vehicle with no electric.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
